**MOTION FOR CRIMINAL CONTEMPT OF COURT**

**TO THE HONORABLE JUDGE OF SAID COURT:**

**NOW COME** Plaintiffs, Bat World Sanctuary and Amanda Lollar, Movants herein, and request that Mary Cummins be held in criminal contempt of court. In support of this motion, Movants will show the Court the following:

**I.**

On November 28, 2011 this Court signed an order ordering Mary Cummins to furnish and disclose to Randall Turner, attorney for the plaintiffs, her home address within **10** days. Defendant, Mary Cummins, has failed and refused to disclose her home address and should be held in contempt of court for her refusal to comply with the Court's order.

On January 10, 2012 this Court signed an order ordering Mary Cummins to pay plaintiffs, Bat World Sanctuary and Amanda Lollar, the sum of one hundred dollars (\$100) each day beginning January 9, 2012 until Mary Cummins discloses her home address to Randall Turner.

As of the date of filing this motion Mary Cummins has refused to disclose her home address to Randall Turner and has stated that she will not disclose that address even though she was ordered to do so by the Court. Mary Cummins has further refused to pay \$100 for each day that has not disclosed her home address.

Mary Cummins has repeatedly and deliberately refused to obey the order of this Court and has contemptuously flouted this Court's repeated order to disclose her address.


II.

Movants pray that Mary Cummins be held in criminal contempt of court and that she be jailed for a period of six (6) months and ordered to pay a \$500 fine.

**WHEREFORE, PREMISES CONSIDERED,** Plaintiffs request that the Court hold Mary Cummins in criminal contempt of Court and commit her to jail for a period of six (6) months and fine her \$500.


ORDER ON PLAINTIFFS' MOTION FOR CONTEMPT

Therefore, the Court finds that Mary Cummins is in contempt of court.

IT IS ORDERED THAT Mary Cummins pay to the plaintiffs, Bat World Sanctuary and Amanda Lollar, the sum of one hundred dollars (\$100) each day beginning January 9, 2012 until


