2 court, as far as producing information about her address and net worth."

3 The Court specifically found that it did not have any evidence in front of it as to why
4 home address should not be produced, therefore, Movant would like the opportunity to
5 present live testimony and written evidence of threats to her that make her fear for her
6 personal safety if required to produce her home address. Movant already produced net
7 worth to Plaintiffs. Attached hereto are excerpts of Internet postings containing threats
8 to Movant.

9 WHEREFORE, Movant requests that on final hearing on this matter, the Court
10 reconsider its earlier ruling and enter its protective order, and grant the Movant
11 protection from having to disclose her home address and grant such other and further
12 relief to which Movant may show herself entitled.

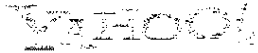

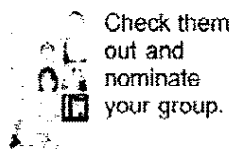
