

DEFENDANT’S NOTICE TO JUDGE RYMELL, CONFLICT OF INTEREST

Defendant hereby notifies this court of a conflict of interest. Defendant just realized that Defendant contacted Judge Jennifer Rymell’s husband Chuck Noteboom about the elements of this case and another case previously. Defendant did not know at that time that Chuck Noteboom had a relationship with Judge Jennifer Rymell.

February 16, 2016 Defendant received an email from Chuck Noteboom. Chuck Noteboom emailed Defendant encouraging her to vote for Justice Debra Lehrmann for Texas Supreme Court. Noteboom stated Defendant should vote for Justice Lehrmann as Justice Lehrmann has been a friend of Chuck Noteboom’s for over 30 years (Exhibit 1). As Defendant does not live in Texas Defendant thought someone added Defendant to Noteboom’s email list without permission.

Defendant then searched Noteboom’s name in emails and saw original emails between Chuck Noteboom’s firm, lawyers and Defendant. Attached as Exhibit 2 is only the confirmation of initial contact. Defendant does not give up the privileged nature of the actual communications or records Noteboom requested and received from

Defendant. There were more emails which went into the details of the cases. Defendant still did not sign up to an email newsletter.

Defendant believes this could prejudice Judge Rymell in this case. Defendant requests Judge Rymell to recuse herself.
