MC-025 - Attachment 4 - Relationship of Parties

June 18, 2010 I traveled to Mineral Wells, Texas to intern at Bat World Sanctuary. Amanda Lollar is the president of Bat World Sanctuary which is located in her home. She was supposed to teach me advance bat care but did not. Instead I witnessed animal cruelty and neglect which I reported. I returned home June 29, 2010.

MC-025 - Attachment 7a(3) - Describe Harassment

July 2, 2010 I first reported Amanda Lollar and Bat World Sanctuary for animal cruelty, animal neglect, violations of the health code, Animal Welfare Act, Texas Parks & Wildlife violations. They were investigated. Violations were found. The USDA vet stated that Amanda Lollar caused bats "pain," "suffering," "death" and she violated the Animal Welfare Act (Exhibit 1). Amanda Lollar has been defaming, harassing, attacking, spamming me ever since in retaliation. She also sued me for defamation stating my reports to government agencies were defamation. I've gone through the police and humane academy and know how to investigate and report animal cruelty. I am on the HSUS Animal Cruelty, Rescue and Response Team.

May 10, 2011 Lollar posted online in a public website that I have a criminal record, I committed petty theft, forgery, theft by forgery and credit card fraud which is not true (Exhibit 2). I have never been charged with or convicted of a crime in my life. I went through the police academy, have a permitted gun and have professional licenses which require strict background checks by the Department of Justice.

May 12, 2011 Lollar posted a death threat against me online, i.e. "If Karma is paying attention, it needs to strike Ms Cummins with a mighty blow so that she's no longer here or a vegetable and harmless" (Exhibit 3).

November 2011 I found an M-80 firecracker under the front of my car in my driveway. It looked like someone tried to light it and threw it but the wick did not stay lit. I live in a wild fire area in the canyons. I took the M-80 to fire station #71 and gave it to them to dispose of as they are dangerous and illegal.

December 30, 2011 I found a broken incendiary device in the same place under my car. It looked like someone made a molotov cocktail, lit it, threw it, it hit the curb and the top broke off into the street. I contacted the police (Exhibit 4). As per the LAPD arson investigator the bottle contained gasoline and solvent. They asked me if anyone disliked me and I told them Amanda Lollar but I didn't think she had my address. She actually did have my address.

February 17, 2013 I saw a man enter a private banquet room and approach me. He showed me some papers so I thought he was serving me legal papers. I followed him towards the exit door when I noticed a different man videotaping me. I told him I don't allow him to videotape me or load the video on the Internet. He did not stop. Then the other man hit me with the documents in the stomach as I turned away.

When I looked at the papers later I realized they were not valid papers that needed to be served on me. I contacted the attorney on the papers and he said in email he didn't send a process server, had no idea who the guy was, he had nothing to do with it, he filed a notice of inability to serve the previous month (Exhibit 5). Amanda Lollar then posted the video on the Internet in her own YouTube channel. You could tell that one man was videotaping normally and the other man had a hidden video camera in his

glasses. I copied the video¹. I was able to identify the person who hit me as Robert Young a PI from Orange County.

February 25, 2013 I filed a police report #131506821 (Exhibit 6). Robert Young admitted to police he was the person in the video. He admitted he was paid by Amanda Lollar to do what he did and videotape it. He lied and said he dropped the papers at my feet. He also clearly edited the video which he posted. It also was not part of a legal service. LAPD told me to also file a police report in Mineral Wells, Texas where Amanda Lollar resides because that is where she ordered this job. I filed a police report by phone February 25, 2013 with the Mineral Wells police department (Exhibit 7).

March 18, 2013 Amanda Lollar called up my bank pretending to be me. She illegally obtained my social security number in discovery. Her lawyer defied a protective order and illegally shared this with his client. I filed a motion for contempt. Lollar used that information to try to access my bank account and the account for my non-profit. My banks refused her access because she couldn't answer the security questions. They notified me in writing. I went into the bank and heard the recorded phone conversations. It was Amanda Lollar's voice. I filed a police report March 19, 2013 for identity theft report #130108757 (Exhibit 8). Someone has recently used my identity to try to get a car loan, home loan and money from the government.

Form MC-025 - Attachment 7a(5)-Harm or Injury

I have suffered extreme emotional distress because of the harassment. I have problems sleeping and I live in fear of being attacked at any time. I fear she will have someone burn down my house and kill my animals. I run a wildlife rehabilitation facility as a volunteer for the California Department of Fish & Wildlife out of my home. We have native wildlife being cared for on the property which could be harmed or killed. I have also suffered financial losses from the defamation she's posted online. Anyone who Google searches my name which basically see only her false defamation. I also have a fear of setting appraisal or animal care appointments never knowing when I'm going to be set up again to be attacked. I fear the next time I go to Texas she may have someone physically attack me.

November 3, 2010 Amanda Lollar hired a PI to lure me through false pretenses to a boarded up Motel 6 over an hour from my house. The PI Robert Young emailed me that he had a baby albino squirrel that would die if I did not instantly drive over an hour in traffic during a heat wave to pick it up. He lied and said his daughter found my contact information on the Internet. I instantly hopped in my car with a pet carrier and drove over an hour to the Motel 6 parking lot where he told me to meet. The Motel was closed and had no trespassing signs all over. I still parked in the lot as instructed. Robert Young drove to me and asked me my name. He then parked his car and motioned me to his truck where he had an animal cage. Then he pulled the legal papers out of the cage. Another man also trespassed onto the property and was videotaping me unbeknownst to me. Amanda Lollar then posted that on her YouTube channel. I did not know I was being videotaped. I did not allow the video to be posted. The video was not legal because everyone was trespassing. They still refuse to remove it. They did not have to serve me in this manner as I am at public adoption events every weekend and always post the address. They did this to harass and embarrass me.

July 2010 to the present Amanda Lollar, her husband Larry Crittenden and a few other Bat World Sanctuary volunteers and fans have been harassing and defaming me and my non-profit Animal Advocates online on Google/Blogger, YouTube, Facebook, GuideStar and other websites. Amanda Lollar bought many domain names with my name in them i.e. marycumminsgoogalebomb.com which she hosts in her website i.e. marycumminsgoogalebomb.batworld.org devoted solely to defaming me. She has posted many totally false articles, blogs, links and comments about me stating I commit animal cruelty, I stole from my grandmother, I sued my grandmother, I'm a convicted criminal, there's a bench warrant out for my arrest, I was picked up by the police, I put a rubber band on a female skunk's penis, I posted her sealed financial documents, I killed my neighbor, I killed my neighbor's cats, I sued an ex-boyfriend... All of these things and much more are completely untrue. She emailed these things to government agencies, my friends, volunteers, fans, clients...

Lollar also makes many personal comments about my physical appearance stating I'm fat, ugly, old, bald, wrinkled, fugly, buttugly, look like shit.... She is completely obsessed with talking about my physical looks for no apparent reason.

Before and after hearings in Texas Amanda Lollar, her husband Larry Crittenden and other members of Bat World come up to me and say things such as "how does it feel to get your ass kicked by a ninth grader." John Hyatt an elderly man who is the husband of Dotti Hyatt board member of Bat World likes to come up to me, get directly in my face while making menacing poses and facial expressions like he wants to fight me physically. I finally had to tell the Judge and parties that I will be videotaping when I'm in the hallway. I intentionally would get to court early so I could enter the court room as soon as the bailiff unlocked the door.

She has signed me up for spam email and phone calls. She signed me up for dating for people over 60, senior citizen dating, asian dating, jewish dating, black dating, wrinkle cream, hair replacement surgery, weight loss, bankruptcy. She also signs me up for auto insurance quotes using all of my real information. Within minutes my phone completely fills up and I receive a ton of email spam. She has made xxx dating profiles using my information and photos.

Through the results of subpoenas I sent to Google, WordPress, Twitter, Yahoo, YouTube, Facebook, Blogger, GuideStar... and website logs I was able to ascertain that the main poster of these items is Amanda Lollar. She thinks she is anonymous but she is not. She emails these same things to me directly pretending to be someone else even though I've sent many cease and desists emails to her and her attorney. She pretends she is user Rachel Thompson but I can clearly see all of her computer identification every time she emails me even when she uses a different ISP. Amanda Lollar has not gone past the eighth grade if that. She is completely uneducated and has social issues most likely stemming from dropping out of school at such a young age. I am not the only person she has been attacking. She's been attacking many other people for at least the last 20 years. People have also been reporting her to authorities for the same amount of time.

Amanda Lollar is now making posts on her Facebook page to incite her fans to attack me. They are attacking me. She is encouraging people to harass me online, report my web pages, photos and content. She posted that everyone should report me for animal cruelty to Fish & Wildlife and the Fish & Wildlife Commission. She posts their email addresses and as per state information act requests results people have been sending in false reports about me.

Lollar has been sending threatening legal letters to web hosts demanding that they remove my content or she will sue them. She lies and states that I posted her personal information, sealed financial documents, defamation and libel which is totally untrue. I have never defamed her or posted her sealed financial documents. I accidentally received her social security number from a police report. I have never posted it online or shared it with anyone other than her attorneys. The web hosts get sick of all her complaints so they remove my content even though it doesn't violate any term of service, law or court order.

Lollar posted video from my deposition which she highly edited. She took the video herself, not a professional. She added subtitles because the audio quality was so poor. I never gave her permission to post my deposition video. She made over 100 movies and currently has 70 movies about me online on her YouTube channel³. She refuses to remove them. She told YouTube that I gave her permission to post them online. I did not. She edited the videos to the point that they are defamatory and misleading.

They can't break the law in regard to me. They must remove their posts, blogs and websites about me from the Internet. She can't sign me up for spam. She can't make profiles pretending to be me. She can't call my bank, talk to my neighbors, colleagues, my volunteers, family or friends.

Hi All

I wanted to include another line about suffering in my previous analysis of this procedure.

I have reviewed the U-Tube footage and looked at the complaint about the bat that was mishandled by Ms. Amanda Lollar of the Bat World Sanctuary. This is indeed a violation of the AWA. Ms. Lollar should have sought veterinary assistance for the bat with dystocia. It would be one thing if she were only assisting a birth, but the moment Ms. Lollar realized this was a dystocia requiring an episiotomy, she should have taken the bat to her attending vet or a local veterinarian. Apologizing in the video to the bat does not solve the problem. This mother bat clearly experienced pain and suffering at Ms. Lollar's hand, so much so that it appeared to lose consciousness during the procedure. No anesthesia was given to the bat and no pain management was offered. I believe the mother bat could have survived if it had been properly anesthetized and the pup delivered using proper surgical techniques. It is possible the pup could also have survived if this case had been properly managed by a veterinarian.

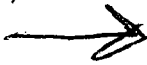

Amanda Lollar lives at 217 N Oak Ave, Mineral Wells, Texas not too far from the police station. She used to own the building down the street from you before she sold it this past January. Anyway she hired a process server to supposedly serve me with valid legal documents. He trespassed onto private property pretending to serve me with legal documents. The documents were void and did not have to be served at all. He was not acting as a process server. Instead of handing the documents to me or dropping them on the floor he hit me with the documents. His friend videotaped this and gave Lollar the videotape which is posted online at Photobucket. The time/date stamp reads 2/17 09:26:38 a.m. California time. Amanda Lollar paid this guy to assault me and videotape it. She also posted a death threat against me stating that I should be killed or left a vegetable. I've attached her driver's license.

I really need to file this report because her violence against me has been escalating. I believe she sent someone to my house recently. I heard women talking next to my gate. I went out back with my permitted gun loaded safety off and could hear them on the other side of the gate saying "do you really think this is her house? Should we open the gate?" It would not have been wise if they'd opened the gate with me standing there. I've sent her three cease and desists telling her to stop harassing me but she refuses to stop.

If the detective is not available when you call, please leave a message and include the telephone number where you can be reached.

COPY OF REPORT: If you wish to purchase a copy of the complete report, phone (213) 486-8130 to obtain the purchase price. Send a check or money order payable to the Los Angeles Police Department to Records and Identification Division, Box 30158, Los Angeles, CA 90030. Include a copy of this report or the following information with your request: 1) Name and address of victims; 2) Type of report and DR number (if listed above); 3) Date and location of occurrence. NOTE: Requests not accompanied by proper payment will not be processed.

DR NUMBER: If not entered on this form, the DR number may be obtained by writing to Records and Identification Division and giving the information needed to obtain a copy of the report (see above paragraph). Specify that you only want the DR number. It will be forwarded without delay. There is no charge for this service.

CREDIT CARDS/CHECKS: Immediately notify concerned credit corporation or banks to avoid possibility of being liable for someone else using your stolen or lost credit card or check.

HOW YOU CAN HELP THE INVESTIGATION OF YOUR CASE:

- * Keep this memo for reference.

Their staff may also assist you with other problems created by the crime.
