






1 Defendant can't stand over five minutes at a time or sit over 20 minutes at a time. If

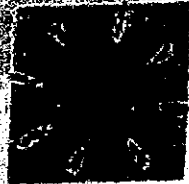
