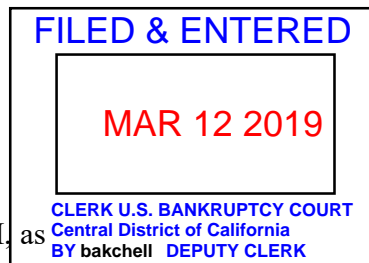

1 On February 12, 2019, the Motion of Plaintiff Konstantin Khionidi, as Trustee of the Cobbs
2 Trust, to Compel The Deposition of Mary Cummins-Cobb came on regularly for a hearing. Plaintiff
3 was represented by Philip H. Stillman and Stillman & Associates and Defendant Mary Cummins-
4 Cobb (“Defendant”) appeared *in pro per*. After considering the papers filed as well as the argument
5 of the parties and good cause appearing, the Motion is granted on the following conditions:

- 7 1. The deposition of Defendant Mary Cummins-Cobb shall be held at the office of a court
8 reporter to be selected by Plaintiff.
- 9 2. The deposition of Defendant can be videotaped by an official videographer.
- 10 3. Defendant can privately videotape the deposition, provided that (a) any videocamera
11 capture both counsel and the deponent in a manner consistent with Fed. R. Civ. P.
12 30(b)(5)(B), (b) the private videotape or any transcript made from the private videotape
13 shall *not* be an official record of the deposition and may not be used as a record of the
14 deposition in any proceedings and (c) if defendant chooses to videotape the proceedings,
15 (i) she may not use the videotape for any purpose, (ii) Defendant may not disseminate or
16 cause the videotape or a transcript made from her videotape or any copies of the
17 videotape, either publicly or privately to any third person, website, blog, internet site,
18 email, DVD, or any other mode of transmission, without a prior order from this Court
19 upon noticed Motion.
- 20 4. Neither Plaintiff nor Defendant may not disseminate or cause any videotape of the
21 deposition of Defendant or a transcript made from any videotape or any copies of the
22 videotape, either publicly or privately to any third person, website, blog, internet site,
23 email, DVD, or any other mode of transmission, without a prior order from this Court
24 upon noticed Motion.

- 1 5. As the court stated at the hearing, the parties are to agree upon a date and time for the
2 deposition of Defendant, and if they are unable to do so, Plaintiff is to contact the court
3 though the judge's law clerk for a telephone conference at which time the court will order
4 a date and time for the deposition.
- 5 6. Defendant's request for a protective order covering the deposition is denied.
- 6 7. Defendant's request that her deposition only proceed after Defendant takes the deposition
7 of third party Amanda Lollar is denied.
- 8 8. Plaintiff's request for sanctions against Defendant is denied for the reasons stated on the
9 record.
